

Summary Annual Report

For Penmac Staffing Services 401(k) Retirement Savings Plan

This is a summary of the annual report Form 5500 Annual Return/Report of Employee Benefit Plan for Penmac Staffing Services 401(k) Retirement Savings Plan, Employer Identification Number 43-1625388, Plan No. 001 for the period January 01, 2024 through December 31, 2024. The Form 5500 annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA). Your plan is a Single-Employer defined contribution plan, which include the following characteristic(s) of 401(k), 401(m), Default Investment Account, ERISA Section 404(c), Participant-Directed, Pre-Approved Pension Plan, Profit-Sharing.

Basic Financial Statement

Benefits under the plan are provided through a trust fund. Plan expenses were \$755,612. These expenses included \$27,113 in administrative expenses and \$724,428 in benefits paid to participants and beneficiaries and \$4,071 in other expenses. A total of 5182 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$4,798,430, as of December 31, 2024 compared to \$4,375,031 as of January 01, 2024. During the plan year, the plan experienced an increase in its net assets of \$423,399. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$1,179,011, including employer contributions of \$82,721, employee contributions of \$273,677, other contributions of \$341,329, gains of \$0, from the sale of assets, and earnings from investments of \$481,284.
